A petition under Sections 230 to 232 of the Companies Act, 2013, for sanctioning the Composite Scheme of Amalgamation and Plan of Merger amongst Reliance Holding USA, Inc. and Reliance Energy Generation and Distribution Limited and Reliance Industries Limited and their respective shareholders ("**Scheme**") was admitted *vide* Order dated June 23, 2020 by the Hon'ble National Company Law Tribunal, Mumbai Bench ("**Tribunal**"). The said Petition



is fixed for final hearing before the said Tribunal on July 27, 2020 at 10.30 A.M. or soon thereafter.

The Tribunal has by its Order dated May 1, 2020 ("**the Order**"), *inter alia*, directed the Transferee Company 2 to serve a notice of hearing of the petition upon its Unsecured Creditors, who may submit representation, if any, to the Tribunal, in connection with the proposed Scheme and that a copy of such representation shall simultaneously be served on the Transferee Company 2.

Somani Marg, Chamundeshwari Nagar, Cuffe Parade, Mumbai 400 005 and a copy thereof be served upon us at our registered office, not later than two days before the date fixed for final hearing of the said Petition.
