Do you wish to speak at the AGM?

Procedure:

1. If you wish to speak at the AGM, please register yourself by filling-up an online form at: <https://jioevents.jio.com/rilagmspeakerregistration>
2. Once you have clicked the above given weblink for Speaker Registration, you will be required to fill in the following details:
 - your DP ID and Client ID
 - location: city and country
 - occupation / profession
 - contact details (e-mail / mobile no. etc.)
 - details of internet connectivity etc.
 - your photograph (passport size - in .jpeg / .jpg / .bpm file)
3. Click on "**Submit**" to register your application.
4. An **acknowledgement** message will be generated and flashed on the screen on successful registration of your application.
5. Company's representatives would connect with the shortlisted prospective Speakers to check the infrastructure, bandwidth and internet connectivity (upload and download speed) available at the Speaker's location and to guide them on the further process.
